Evidence of a policy of general liability insurance insuring against any property damage in an amount not less than \$1,000,000 per occurrence and \$2,000,000 aggregate for general liability. 1,000,000 CSL automobile liability (hired & nonowned automobile coverage to be included), \$500,000/\$500,000, \$500,000 employer's liability (workers' compensation policy), \$10,000,000 commercial umbrella liability. Such policy shall name the City of Stamford, the DSSD, its agents, employees and representatives as additional insured and contain a provision stating that the District will be notified not less than 30 days in advance of the cancellation of any such policy.
