### Request for Proposals (RFP)

### Public Realm Beautification, Urban Forestry, AND Snow Removal/Winter Weather Response

### Stamford Downtown Special Services District (Stamford Downtown) Stamford, CT

#### Description of Amendment

Stamford Downtown offers prospective vendors the opportunity to respond to portions of the scope of work outlined in this document, in lieu of requiring prospective vendors to submit a response addressing all elements of the scope of work.

Stamford Downtown has sub-divided the scope of work into the following elements:

Element One – Gardens and Ground Planters

Element Two – Hanging Baskets

Element Three – Urban Forestry

Element Four – Snow Removal and Winter Response.

Stamford Downtown requests vendors formulate responses to all, or a portion, of these elements in accordance with the requirements listed in this document.

#### Scope of Work

Element One – Gardens and Ground Planters

Stamford Downtown's Public Realm Beautification Program includes:

Twenty **garden** areas located along the street-level or within City-owned parks including a bioswale and four pollinator gardens,

and

Seventy-plus **ground planters**.

The locations of the street planters and gardens are illustrated in the attached maps.

The contractor's scope of work will include, but not be limited to:

Planting designs and purchase of requisite plant materials,

Watering plantings, disease prevention and replacement of any diseased plant materials within seventy-plus **ground planters**,

Planting, watering, fertilization, disease prevention, maintenance, and replacement of any diseased plant materials within of **gardens** at multiple locations including four (5) public parks (Latham, Columbus, Kiwanis, Rippowam and St. John's)

Watering of all **planters** and **gardens** is required, as needed, through the end of June and daily from July 1<sup>st</sup> through Labor Day then again as needed until the end of October. Watering is to take place in the early morning while traffic volumes are lower,

Removal of trash from planters while watering.

Note, Stamford Downtown requires the selected vendor to assign a staff member, with demonstrated landscape design and maintenance expertise, to the Stamford Downtown account. This staff member will have a daily presence downtown to observe plantings, coordinate maintenance and watering, schedule seasonal changes in plant materials, ensure replacement of damaged plant materials and provide regular written, monthly reports to Stamford Downtown. Stamford Downtown is reliant on the selected vendor to proactively replace diseased or dying plantings.

## Element Two – Hanging Baskets

Stamford Downtown’s Public Realm Beautification Program includes two hundred plus **hanging flower baskets**.

The contractor’s scope of work will include, but not be limited to:

Installation, watering, fertilization, disease prevention and replacement of any diseased plant materials within two hundred plus (200+) **hanging baskets** as needed from approximately Memorial Day to Columbus Day (Installation will begin at 4:30am and continue until completion),

Removal of **hanging baskets**, and preparation for delivery for winter and

Removal and installation of **hanging baskets** in response to severe storm conditions (estimate two (2) storm events).

Stamford Downtown requires the selected vendor to assign the necessary personnel, with demonstrated landscape design and maintenance expertise, to the Stamford Downtown account. This staff member will have a daily presence downtown to observe plantings, coordinate maintenance and watering, ensure replacement of damaged plant materials and provide regular written, monthly reports to Stamford Downtown. Stamford Downtown is reliant on the selected vendor to proactively replace diseased or dying plantings.

### **Element Three – Urban Forestry and Green Infrastructure**

Within the past year, Stamford Downtown has worked with the City of Stamford and a consortium of stakeholders including the Mill River Collaborative, the Bartlett Arboretum, the Stamford Pollinator Pathway and Future 5 to initiate an urban forestry initiative. By Memorial Day 2024, the outcomes of this initiative will result in the planting of twenty-four trees and the expansion of sixteen tree beds. The selected vendors will monitor the newly planted trees and assist with watering as needed.

As part of this initiative, Stamford Downtown is actively working to ensure all tree beds within the public realm meet the standards of the City's Street Tree Manual. Compliance with the Street Tree Manual often requires expansion of existing tree beds, planting new, or pruning existing trees and the installation of permeable tree bed treatments such as Flexi-Pave.

In addition to watering and monitoring those trees already incorporated into Stamford Downtown's urban forestry efforts, Stamford Downtown seeks a vendor that can provide on-call urban forestry services including, but not limited to, expanding, or combining tree beds, installing trees and permeable tree bed treatments.

## **Element Four – Snow Removal and Winter Weather Response**

In addition to its Public Realm Enhancement Program, Stamford Downtown requests proposals from contractors for clearing snow from downtown sidewalks, crosswalk curb cuts and bus stops.

### **Scope of Work**

Approximately 34,000 linear feet of sidewalk and approximately 280 curb cuts at crosswalks and bus stops, cleared to a width of four feet. (See map attached) Work shall begin after snowfall depth of 2" or more and be completed within four (4) hours after snowfall ceases. The selected vendor will lightly sand and/or salt problem areas during and immediately following snow removal. The vendor will consult with Stamford Downtown to determine if pre-treatment is necessary prior to snow events or instances of freezing rain.

For the purposes of administering its winter response program, Stamford Downtown has segregated streets into three categories:

### **Primary Streets**

Primary Streets (approximately 17,000 linear feet) are those streets that are the most heavily trafficked by pedestrians and are associated with Stamford Downtown's three restaurant sub-districts (Bedford, Lower Summer and Main). Stamford Downtown's vendor and Stamford Downtown's Environmental Maintenance Team (overseen by Block-By-Block) will focus their efforts within these areas by pretreating sidewalks before storms, clearing sidewalks, curb cuts and bus shelters.

### **Secondary Streets**

Secondary Streets (approximately 17,000 linear feet) are those streets serviced by vendors of large, floor-plate commercial and residential buildings. Stamford Downtown's vendor will actively monitor these streets to ensure private vendors are clearing sidewalks and curb cuts. If necessary, Stamford Downtown will supplement municipal and private services by clearing sidewalks, curb cuts and bus shelters along these streets. Stamford Downtown's vendor must track the time and materials needed to address secondary streets during each storm.

### **Transportation Corridor**

Stamford Downtown's vendor, with support from Stamford Downtown's Environmental Maintenance Team, will take the lead in ensuring the curb cuts and walkways leading to the Stamford Transportation Center remain open during a snow event. Stamford Downtown created this street classification in response to the vital role mass transit plays in serving downtown.

See attached map for detailed illustration of these street classifications.

Note, the uniforms of the selected vendor's winter weather staff must identify the vendor as working on behalf of Stamford Downtown.

## Format of Response

Please submit the following:

1. Written background of your firm including a description of the firm's related project experience
2. Photos samples of related experience
3. Description of, and resumes for, the project management team assigned to this contract.
4. Fee proposal segregated according to the activities cited below (a prospective vendor may submit a fee proposal reflecting all or a portion of the scope of work):

### Element One – Gardens and Ground Planters

Provide a monthly (nine months), fixed price for the following:

Spring preparation,

Four (4) seasonal plantings,

Watering,

Fertilization,

Weeding,

Pruning,

Disease-control,

Fall cleanup and

Ground planter Winter décor.

Note, the vendor will invoice Stamford Downtown separately for the purchase of plant materials. The selected vendor will advise Stamford Downtown whether additional funds for plant materials are necessary.

### Element Two – Hanging Baskets

Provide a monthly (five months), fixed price for the following:

Storage and Spring preparation (including planting for season),

Watering,

Fertilization,

Weeding,



Pruning,

Disease-control,

Removal, and storage, of baskets in response to two storm events and

Removal of hanging baskets, and preparation for delivery for winter.

Note, the vendor will invoice Stamford Downtown separately for the purchase of plant materials. The selected vendor will advise Stamford Downtown whether additional funds for plant materials are necessary.

### **ELEMENT Three – Urban Forestry and Green Infrastructure**

Provide a monthly, fixed price for regularly filling Gator Bag watering systems at twenty-four tree beds.

Estimate the per unit cost for altering an existing tree bed to meet the requirements of City of Stamford's Street Tree Manual. This cost should reflect the following:

Expanding an existing tree bed (presume 4'\*5') to meet the requirements of the City of Stamford's Street Tree Manual (4'\*10')

Removal of existing pavers or steel grate,

Excavation and installation of soil at proper depth,

Installing a new tree and

Installation of permeable tree bed treatment such as Flexi-Pave.

Note, Stamford Downtown seeks a vendor that is a certified, Flexi-Pave installer OR has an on-going working relationship with a certified installer.

### **ELEMENT Three - Snow Removal and Winter Weather Response**

The proposed estimate for this element should reflect the varying level of service required for Primary Streets/Transportation Corridor and Secondary Streets.

#### **Primary Streets and Transportation Corridor**

Provide your recommendation for the number of clearings per storm based on various snowfall depths.

Your estimated cost per clearing is based on various depth increments.

Your estimated annual cost is based on a five-year average snowfall.

Description of equipment, supplies and personnel projected to be employed.

#### **Secondary Streets**

Provide an estimate of time and materials needed to monitor and supplement existing services along Secondary Streets

### **Format of Contract and Submission Requirements**

The term of the contract is Calendar Year 2024.

The terms of the Gardens, Planters, and Urban Forestry elements are March 1, 2024 – November 30, 2024.

The term of the Hanging Basket element is May 27, 2024 (Memorial Day) – October 14, 2024 (Columbus Day).

The term of the Snow Removal and Winter Weather Response element will begin on the day of the first snowfall greater than 2" after November 1, 2024.

Stamford Downtown reserves the right to execute two, one-year options for each element.

Stamford Downtown will provide compensation on a fixed-price contract except as stated above.

Stamford Downtown may choose to add areas or projects to this scope.

A prospective vendor's response should include an hourly rate for time and materials for additional projects requested by Stamford Downtown.

A mandatory walking tour will take place on December 19, 2023, at 10am. Prospective responders will meet at 677 Washington Boulevard across from the main entrance of the Stamford Transportation Center that fronts on North State Street.

Stamford Downtown reserves the right to host interviews of prospective vendors. If requested, prospective vendors will interview on Friday, January 19, 2024. Stamford Downtown anticipates final vendor selection by no later than January 31, 2024.

### **Equal Employment Opportunity**

Stamford Downtown does not discriminate based on race, color, religion, national origin, sex, age, disability, genetic information, or any other status protected by law or regulation.

All bidders must be able to meet the following insurance requirements and provide a Certificate of Insurance (Col) reflecting:

General Liability - \$1,000,000 Occurrence/\$2,000,000 Aggregate

Excess/Umbrella Liability - \$5,000,000 occurrence/aggregate

Workers' compensation – statutory requirements w/ Employer's liability of \$500,000/500,000/500,000 Commercial Automobile - \$1,000,000 combined single limit to include owned autos (if applicable) and hired & non-owned autos.

Such policies shall name the DSSD and the City of Stamford as additional insured and contain a provision stating that the DSSD will be notified not less than 30 days in advance of the cancellation of any such policy.

Stamford Downtown will require the selected vendor, or vendors, to execute a Hold Harmless Agreements.

Stamford Downtown will provide a sample Col and Hold Harmless Agreement upon request.
