



Request for Proposal – Event Bleachers for 2024 Parade

General Information

Stamford Downtown produces signature concert events that greatly contribute to the economic vitality of Stamford Downtown.

The Stamford Downtown Parade Spectacular is one of the largest helium balloon parades in the country with 15 balloons, 18 marching bands and many dance troupes. This single day event in Stamford CT attracts over 150,000 spectators. This annual is held the Sunday before Thanksgiving. This year's date is 11/24/24.

Stamford Downtown Special Services District (DSSD) is requesting proposals of a full-service bleacher production company. The interested parties should be able to address the needs of DSSD in the most efficient manner possible.

Program Objective: To produce Signature Events that contributes significantly to the economic vitality of DSSD.

Scope of Work

Stamford Downtown Parade Spectacular—Sunday, November 24, 2024

1. Production Management:

1. Attend an inspection as required by fire marshals and city officials.

2. Production Services and equipment:

1. Provide, install, and remove bleachers throughout one-mile parade route in several locations to seat 1760 people.
2. Be available to install the week leading up to the parade, as well as the early morning of the parade.
3. Remove all bleachers within 2 days after the parade.
4. Have all necessary city permits for installation and inspection.

3. Labor

1. All labor required to install and remove the bleachers and its associated rigging should be included

The proposal must contain the following items of information:

1. Background and description of the firm
2. A description of the services and equipment that the firm will provide
3. Description of staffing plan
4. Description of the equipment that will be used.
5. A portfolio of large outdoor production and at least three references.
6. DSSD reserves the right to accept or reject all or part of a proposal for any reason DSSD deems advisable.

Insurance Requirements

- a) Evidence of a policy of general liability insurance insuring against any property damage **or bodily injury** in an amount not less than \$1,000,000 per occurrence,
- b) \$2,000,000 aggregate for general liability,
- c) \$1,000,000 CLS automobile) and (hired and non-owned automobile coverage to be included)
- d) \$500,000/500,000/500,000 Employers liability (workers' compensation), \$10,000,000 umbrella. The owner of the venue, the City of Stamford and the DSSD its agents, employees and representatives should be listed as additional insured for general liability with a waiver of subrogation for general liability and workers' compensation and contain a provision stating that DSSD will be notified not less than 30 days in advance of the cancellation of any such policy.
- e) Liquor liability insurance if applicable \$1,000,000 each common cause, \$1,000,000 aggregate.

This Request for Proposals is subject to the specific conditions, terms and limitations stated below:

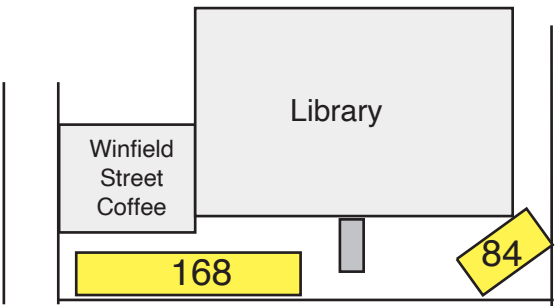
1. No applicant will be selected if it is in default upon any debt, contract or obligation to the Stamford Downtown Special Services District, or City of Stamford.
