LETTER FROM THE PRESIDENT, SANDY GOLDSTEIN



Over the course of the last decade, it became increasingly clear that there existed a deep chasm between current zoning regulations for downtown development and the reality of the numerous zoning amendments needed to create viable downtown residential and commercial projects. Amendments to facilitate parking, density and height were just a few of the changes necessary to develop significant projects in a 21st century urban center. Because there has never been a comprehensive downtown rezoning effort since the inception of zoning in 1951, currently, the only way to ensure that appropriate, modern development occurs in the downtown is through an amendment process.

The DSSD and the URC recognized the need to jump start a comprehensive rezoning process for the downtown which would articulate new regulations that embrace the downtown's growth, urban character and future development needs. These new regulations would then be presented to the Planning and Zoning Boards for their

consideration. Because the Regional Plan Association wrote the 2002 Master Plan revisions after a thorough community wide process and was therefore very familiar with the downtown, RPA was engaged as consultants to lead an inclusive process which would include roundtables and workshops regarding various aspects of downtown development. Downtown stakeholders, community leaders, developers and other people active in downtown zoning and planning would be invited to the roundtables. Following that, interested citizens would be invited to a community workshop.

There were several basic principles that were integral to the project's scope: the quality and sense of place that is intrinsic to the downtown core must be protected and enriched, the pedestrian experience must be nurtured, transit-oriented development must be promoted, increased density must be recognized as an essential ingredient for a vital urban environment, multiple state-of-the-art parking options which would facilitate cutting edge development must be explored, and best practices in nationwide zoning which ultimately result in quality projects must be researched. Concurrent with the above, the study must identify the ways in which current zoning diverges from the actuality of the zoning revisions for downtown projects approved by the Zoning Board during the last ten years.

Two roundtable discussions were held during the summer. The first dealt with parking and raised numerous issues and questions relating to sound 21st century development including:

- Is excessive parking benign and necessary or does it erode the sense of place and the pedestrian experience?
- Should parking ratios be required in the downtown and geographically tailored to reflect local specificities including availability of public parking, accessibility to transit and other factors which influence behavior?
- How should the preponderance of public parking in close proximity to redevelopment areas be used to encourage private residential development?
- Should there be more significant uses of current and new technologies which have been proven in projects around the country as well as Stamford, such as elevators, lifts and valet parking?

The second roundtable dealt with relevant design amenities which would be useful tools to achieve robust development and which would result in a win-win-win for the city, the developer and most important, the people. Conversation centered on the relative values of amenities such as public art, pedestrian connection, green building technology, affordable housing, bike paths and numerous other thought provoking amenity ideas.


To round things out a community workshop will be held on October 8th at UCONN at 5:30pm. It will provide the community with an opportunity to opine on land use, building form, public realm and regulatory framework for the downtown through a series of interactive design tools. Three dimensional digital models, photo simulations and visual preference photographs will be used to critique various massing and design concepts and their application on key sites. An interactive discussion will enable participants to voice their concerns and visions for the city's core. Anyone interested in attending is welcome to do so. Please call the DSSD or the URC office for more information.

The results of the research, workshops and roundtables will be synthesized into various white papers and a report defining the goals and objectives which would appropriately be included in comprehensive downtown rezoning. The draft reports and zoning revisions will be presented to the stakeholder committees for their input, after which they will be presented to the Planning and Zoning Boards.

Alive @ Five

Thursday nights in the Summer have become something of a ritual for many who make it a point to come down and enjoy the music, atmosphere and vibrancy of our Downtown. On August 6th, more than 12,000 people came to celebrate the Summer and rock Stamford Downtown with Alive @ Five headliner, Sugar Ray. The energy of the crowd was palpable as Mark McGrath, Sugar Ray's front man, known for his on-stage antics, sang hit after hit. On one of the hottest days of the year, the band blasted "Under The Sun," a fan favorite from the group's 2001 album. The tune turned out to be an anthem, providing the perfect coda to a summer season strewn with rainy days and chilly nights.

Despite the inclement weather, the DSSD succeeded beyond expectations with regard to the goals set forth at the beginning of the concert series. New rules, a new festival entrance fee and a new enclosed concert area all added to the challenge of producing a recurring seven week event. From informing the public, to working out the logistics of a main entry gate in the heart of Stamford Downtown, our events team (with the support of the City of Stamford and many fabulous volunteers) was able to "step up" the quality of the series and provide a wonderful opportunity for concert-goers to experience the Downtown.

In addition to the fantastic line-up and operational changes, Alive @ Five 2009 offered even more opportunities for Downtown businesses to participate in this signature Summer event. This year, the sponsor tents were moved off the street and into a brand new food court with tasty options from Remo's Brick Oven Pizza Co., Butterfield 8, Sundance Café & Wine Bar, Rack N' Roll Café, Carvel Ice Cream, Maui Wowi and EOS Greek Cuisine.

By the end of the seven week series, The Heineken Stage was home to the likes of Gilby Clarke, Josh Gracin, Bo Bice, Better Than Ezra, Tonic, Smash Mouth and Sugar Ray, all top notch performers with solid fan bases. Each year Alive @ Five proves that Stamford Downtown really is the place be! And, this past summer 42,000 patrons ensured that it really was the HAPPENING place.

Pops in the Park

With strong acts that run the gamut from show tunes to classical symphonic ensembles, Pops in the Park continues to grow each year. Approximately 3,000 people came out on July 15th to watch 70's sensation, The Stylistics, take the Heineken Stage in Columbus Park. As the crooners hit their harmonies, smiles could be found from one end of the park to the other, as concert-goers laid out blankets, picnic dinners and beach chairs to relax and enjoy the music.

A week earlier, the Stamford Symphony Orchestra, masterfully conducted by Eckart Preu, kicked off the concert series with its Henry Mancini retrospective and other famous composers. Classic scores from well known movies filled the park as patrons sat at the outdoor cafés that lined Columbus Park and enjoyed the 60 piece orchestra. Tiernan's Bar, Columbus Park Trattoria and Market Restaurant were favorites with the Pops crowd, offering comfortable outdoor seating and perfect views of the Heineken Stage.


HOTEL ZERO DEGREES


